2018 MISS NORTHERN LIGHTS' OUTSTANDING TEEN OF WISCONSIN/MISS AMERICA SCHOLARSHIP FUND – SCHOLARSHIP RULES AND REGULATIONS

THE MISS AMERICA SCHOLARSHIP FUND THROUGH THE MISS NORTHERN LIGHTS ORGANIZATION OF WISCONSIN WILL AWARD SCHOLARSHIPS UNDER THE FOLLOWING CIRCUMSTANCES:

1) ALL SCHEDULED APPEARANCES ARE ATTENDED BY MISS NORTHERN LIGHTS' OUTSTANDING TEEN 2018:

- a.) Miss Northern Lights' Outstanding Teen 2018 will attend all appearances scheduled by the Miss Northern Lights Organization. **All appearances made by Northern Lights' Outstanding Teen 2018 must be approved by the Director.**
- b.) Miss Northern Lights' Outstanding Teen 2017 will write Thank You notes to all specified sponsors.
- c.) Miss Northern Lights' Outstanding Teen 2017 will be given the option to attend the Miss Wisconsin Preview Night for Western Wisconsin titleholders (typically a Tuesday or Wednesday in early June). Once she has committed, the decision will stand and she is expected to adhere to the decision. All wardrobe for the Miss Wisconsin's Outstanding Teen Pageant will be worn at the Miss Wisconsin Preview Night.
- d.) Miss Northern Lights' Outstanding Teen 2018 will attend all scheduled appearances and competitions for Miss Wisconsin's Outstanding Teen Prep Day (a Saturday in April) and Miss Wisconsin's Outstanding Teen 2018 (at least 3 days in June)
- e.) Miss Northern Lights' Outstanding Teen 2018 will attend and fulfill obligations, which will include but not limited to: emcee, performer, and co-organizer of the Princess Program, at the Miss Northern Lights Pageant 2018.
- f.) Consent is given for personal and professional photographs including all contestants, the Miss Northern Lights Pageant, and/or Miss Northern Lights' Outstanding Teen 2018 to appear on the Miss Northern Lights website and other publications.
- g.) No contestant shall cancel her participation within 2 weeks of Miss Northern Lights 2017 after submitting a signed and notarized contract and contract appendix. If a cancelation occurs, the Miss Northern Lights Director will be the final decider on whether to accept said contestant for future participation in any pageant occurring in the year 2019 or after.

2) ALL OTHER RULES ARE FULFILLED:

a.) Wardrobe for the 2018 Miss Wisconsin's Outstanding Teen Pageant must be approved by the Miss Northern Lights Organization no later than June 1, 2017. Wardrobe attire is the sole responsibility of the contestant. All competition wardrobe must be approved PRIOR to purchase by the Miss Northern Lights director. Miss Northern Lights 2018 will work with her director to choose competition wardrobe and a final decision will be made together.

3) SCHOLARSHIP USAGE:

Scholarship money awarded should be used toward future educational opportunities.

I have read and understand the above statements. By signing the Contract Appendix, I understand I will fulfill the obligations of Miss Northern Lights' Outstanding Teen 2018. If I do not fulfill said obligations, I will forfeit my local title, local scholarship, and state scholarship(s).
